☐ Fences – Approval on a case by case bases.
☐ Easements must be maintained within 5 feet of all rear, front & side lot lines.

Visual Appeal (check all that apply)

☐ Does not block the view of the road or lake (unless a signed waiver is included from neighbors).
☐ Only new materials may be used in the construction of a residence.
☐ Exterior surfaces must be finished or painted.
☐ Any garage or utility structure must conform in appearance to the residence.

Attachments (to be included with the application)

☐ **3 copies** of a drawing/picture/survey copy/permit request with structure dimensions and setbacks to lot lines.
☐ Fee check to be made out to LSPOA [Check #_____]

Note: In addition to the items noted above, all construction must comply with the Restrictive Covenants for the subdivision in which the construction will take place. Permits are not required for docks, driveways or landscaping. The structure must be in compliance with the LSPOA Bylaws and state the local regulations as noted on our website at www.lakesomerset.org. In the event that the Building Control Committee has not responded within 15 days of submission of this form, the owner should contact the chairman of the Building Control Committee for the status of the request.
